4. Details of our assessment

This was a routine, unannounced site inspection visit by Waste Regulation Officer, Joe Weatherley.

Upon arrival at site, the officer was greeted by a site operative who accompanied the officer to the site office and requested that he sign the attendance sheet. The site permit was available and visible, attached to the noticeboard in the office.

The operative then accompanied the officer during the site inspection. All waste types were segregated, labelled and contained in their individual skips. Fridge freezers were stored inside a weatherproof, sealable shipping container.

The perimeter fence was in good order, with no breaches or weaknesses visible. The site was subject to an arson attack on 26/06/2024. This was reported to Natural Resources Wales on 27/06/2024. The fire was extinguished by North Wales Fire and Rescue Service and the resulting fire water, successfully contained by the site's sealed drainage system. Please provide Natural Resources Wales, with copies of waste transfer notes pertaining to the removal of fire water from the site, by Friday 10th January 2025.

The officer is in possession of a working plan for the site dated 1st April 2010. This document is headed with "CAD Recycling LTD", who were the site operator prior to Brysons Recycling. Natural Resources Wales will contact the site manager and request a copy of any updated working plans produced since this date.

The site appears to be functioning well and operating within the conditions of the site permit.
