During the site inspection, it was noted that a piece of timber had been attached to the bottom of the abstraction weir. This is not permitted as it poses a risk to fish passing over the screen.

It was also noted that stones were beginning to accumulate near the compensation notch although they were not yet impeding the flow, care must be taken to maintain the impoundment in order to prevent this from deteriorating and blocking the notch.
