4. Details of our assessment

Natural Resources Wales officer Ffion Jones attended Cwm Irfon Hydro scheme site for inspection on the 28th June 2023.

The discharge point did not have a mesh screen that and therefore, inappropriate to prevent fish/eel access towards the turbine. Please see photograph below. **Please ensure that condition 9.6 (ii) of your environmental permit is met by the 24th September 2023 - send photographic evidence to**

Condition 9.6 (ii) - No abstraction shall take place unless the Licence Holder has installed a mesh screen with spacing no greater than 12 millimetres to the discharge outlet pipe to prevent the entrapment, entrainment or impingement of fish.
