On the 8th of January 2019, my colleague and I conducted a routine inspection at Nant Y Wenynen hydropower scheme.

### Infrastructure - Breach (B4) Containment of stored materials

Measurements were taken of the scheme including the Hands off Flow Notch (HoF). The dimensions of the HoF are significantly smaller than those submitted with the permit, resulting in a lower flow than necessary being conveyed through the HoF notch.

At present the HoF measures 60mm high by 30mm wide, whereas the plans submitted specify that it should be 150mm high by 70mm wide.

### Infrastructure - Breach (B1) Engineering for prevention and control of emissions

During the inspection a simple flow test was conducted. Over 2.5 seconds approximately 4 Litres was captured leaving the Hands off Flow notch, whereas the permit requires 4.7L/s to flow through every second.
