The Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) following the submission of the Q3 monitoring returns.

**Q3 Monitoring Returns (July to September 2024) - Emissions to Water**

The Q3 Returns for July, August and September were submitted on 5 December 2024. The late returns are a **breach of Condition 4.2.3 and have been scored a C4.**

- July 2024 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.
- August 2024 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.
- September 2024 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.

**ACTION 1:** Returns are to be submitted as specified in Condition 4.2.3 *within 28 days of the end of the reporting period.*

## Important information
