4. Details of our assessment

A site inspection was undertaken on Friday 13th December 2024 at the request of the

Operator prior to a permit surrender application being made.

The purpose of this inspection was to identify and assess any lasting impact operations have had on the site.

A site inspection and review of documentation (previous inspection report forms) has been undertaken and the following observations have been made:

Site Inspection

The Environmental Permit for the site (ref: EPR/SP3398FF) allows the Operator to accept, store and treat waste scrap metal and End-of-Life Vehicles (ELVs) although it is noted that End-of-Life Vehicles were not depolluted and/or dismantled on site. Furthermore, it is accepted that the site has not been operational for several years.

The building where End-of-Life Vehicles parts were stored (engines for export etc.) was empty and all waste had been removed. The building itself appeared to be very well maintained and there were no signs of historical leaks/spillages of oils/fluids.

The yard area, where scrap metal waste would have been stored, was also empty and there was no scrap metal waste remaining on site. An inspection of the site surface was undertaken and there was no visual impact from previous years. There was no waste, oils, discolouration of ground. A nearby watercourse was also visually inspected and there was no odour, discolouration or iridescence which suggests there is no contamination of land.

The site itself appears to have been well managed and maintained to a high standard. There did not appear to be any lasting impacts on site from operations.

Documents & Records

A review of our records, including Compliance Assessment Reports from all previous site inspections, has been undertaken.

It is noted that no non-compliances were reported while the site was operational. Previous Compliance Assessment Reports highlight that the site was well maintained and no pollutions occurred during the time the site was operating.

Summary

Following a site inspection and review of our records, it appears operations have not had a detrimental and/or lasting impact on the site.

Records indicate that the site was well managed and maintained and there were no pollution incidents or any other environmental incidents during the time the site was operational.
