4. Details of our assessment

Updated CAR following previous CAR_NRW0043832 issued on the 2.4.2024 in relation to the EDM TEN Investigation for BW2201201 - Rear of Tir Einon, Llanelli Asset ID 52247, which we received on the 12.3.2024.

The Initial Report included the required proposal with timeframes for an investigation into the operation of the overflow. NRW approved the proposal which you now need to act on in order to comply with Condition 3.1.2 (a)(ii) of the permit by investigating the reasons for the

exceedance in accordance with the approved investigation proposals.

On the 10.12.2024 it was confirmed by DCWW that Action 1 was complete as below:

Action 1: Specific action as detailed in the Initial Investigation Report (4.3): CCTV and Alphus refurbishment. On May 15, 2024, an inspection of the Alpheus system was conducted. The flow control was found to be in good condition. The CSO group engineer performed maintenance, which included removing the inlet flow plate to replace the bearings. The jetting crew then washed down the accumulated debris before the inlet flow plate was reinstalled in the correct position.

We request that the next stage of the works, being flow monitoring and asset modelling are undertaken as stated in the initial report with the end deadline being the end of July 2025. We welcome any potential reduction in the timescales.
