4. Details of our assessment

On Thursday the 24th of October 2024 Natural Resources Wales officers carried out a routine unannounced site inspection. The visit was carried out by Waste Regulation Officer Ian Thomas.

On arrival, I. Thomas reported to the site office and met with Joan Chadwick and Frances Chadwick, owners of the site. Frances is also the TCM (technically competent manager) for the business, a copy of the WAMITAB certificate showed it to be in date. Checks on the relevant paperwork and documents were carried out. Waste Transfer Notes and permit all looked to be in order. The EMS (environmental management system), could not be located when requested but, Frances found the document after the officer had left the site and a copy was sent over. All drivers bringing waste to the site must supply their driving licence which is copied and kept with the relevant paperwork. This is to ensure that the waste brought in can be tracked and is from reliable sources.

Frances accompanied the officer on a walk around the operational site. Overall the site is well organised, there are areas sectioned off for the various waste streams and waste batteries are stored within sealed containers until collection.

No de-pollution of cars takes place on site, all gas bottles are locked in a dedicated cage. There is an inside area used for non-ferrous metals and weighing. Frances explained that the site has one interceptor which is monitored and emptied approximately twice a year.

Prior to visiting the site, waste returns were checked and found to be completed and up to date. No issues were found during the inspection, the site looks to be well run and is organised.
