4. Details of our assessment

CARS form generated following visit to the Abergynolwyn Sewage Treatment works on the 16/12/24 at 13:00.

The local environmental officer from Natural resources Wales met the catchment manager for North West Wales, Catchment Operations manager and catchment Ops supervisor from Dwr Cymru.

The Dwr Cymru team showed the officer around the site and explained that the RBC (rotational biological contactor) is currently not in use as its awaiting a repair. Dwr Cymru is currently tankering off site so the site is not currently discharging.

It was noted that works have been approved by Dwr Cymru for repair and are scheduled to be completed in January/February.

For Action, Can Dwr Cymru inform Natural Resources Wales when the work is completed and the site begins to discharge again and stop tankering.
