Site Report

Arrived: 09:50

A compliance visit for the permit was undertaken on 13/12/2024. A Natural Resources Wales (NRW) Environment Officer and Dŵr Cymru Welsh Water Water (DCWW) Resources Technician (South East) were present. The weather was dry and 4°C at Maerdy Water Treatment Works where the inspection took place.

Two abstraction points are listed on the licence for Lluest Wen and Castell Nos reservoirs to be used for public water supply. The Water Resources Technician informed me that there had been no abstraction from Lluest Wen reservoir since 2016. This is due to the water abstraction being too aggressive for the water mains within the area. A CO₂ plant is planned to be installed in AMP 8 to allow its use. I was informed that Castell Nos has the capacity to supply all the water needed to Maerdy Water Treatment Works.

Two inlet flow meters were installed at the site, one for each abstraction on the licence and labelled accordingly. The meter for Lluest Wen read 0.00Ml/day (Photograph 1) supporting the lack of abstraction from the reservoir. The meter for Castell Nos reservoir read 9.6Ml/day (Photograph 2).

Both of these readings were in line with data provided to NRW by DCWW on 09/12/2024 covering the past years abstractions (01/12/2023 – 30/11/2024). An annual abstraction limit of 5809.9MI is specified on the permit as a combined value from both abstraction points. In 2024 a total of 3400.6MI was abstracted.

Maintenance records for the Castell Nos meter were sent to NRW on 16/12/2024 and confirmed that on 27/11/2024 an external company conducted verification on the Fischer & Porter 9507L1035A14/A7 device. Results of the testing were acceptable.
