4. Details of our assessment

This was a pre-arranged inspection to complete an Operator Monitoring Assessment (OMA) Air. The Head of EHS BP (Broughton) was the principal host for the site visit, supported by the wider Environment Team.

This OMA focused on the monitoring of emissions to air from CHP-A3 Skin and Creep Boiler, and CHP-A15 and CHP-A18 space heaters, also known as CHP D and CHP E respectively.

Periodic emission monitoring and assessment is undertaken annually by an MCERTS accredited contractor and UKAS accredited external laboratory.

Overall, there is a good standard for management of annual monitoring. Most aspects of annual monitoring have shown to be at a high level.

Locally there is a reliance on contractor "knowledge" of the site /sample locations with reference being made to historically nomenclature which has the potential to lead to discrepancies in sampling and reporting. All sample locations must be labelled correctly and correlate to the locations identified on the permit. It is recommended that site drawings are updated to reflect this.

A very good level of Quality Assurance was shown by operator.

The OMA report gained a good score of 93%. Please refer to the OMA audit report form on the accompanying email for detailed findings and scoring in accordance with the OMA methodology.
