4. Details of our assessment

I (Environment Officer Gavin Dodd) arrived at Quarry Yard, Cwm-Nant-Yr-Odyn on Wednesday 23rd October 2024 at 14:00 to conduct an inspection regarding a licence to operate a groundwater activity (Permit Number AN0403001).

The permit concerned the discharge into land of trade effluent from an oil interceptor via a soakaway system at ST1857695254. This grid reference was inaccurate. Two workers were on site working on breaking down cars, though this was only done in a shed and not outside. No internal drains were visible in this shed. The owner of the site was not present

to discuss the permit.

One of the workers showed the location of the oil interceptor in a yard adjacent to the shed. Within the chamber was standing water with an intermittent oily sheen. The level of the water was not high enough to enter the discharge pipe and a nearby stream was clear of staining and any odour, though it was unclear if the interceptor was discharging to this stream or elsewhere. No servicing records or maintenance programme was available on site.

Breaches

1.) Condition 4.1.2: The operator shall keep on site all records, plans and the management system required to be maintained by this permit, unless otherwise agreed in writing by the Environment Agency

Justification: Records were not available on site.

Actions required by date specified

1.) Provide the management system, servicing records and plans for the interceptor.

The deadline for this action is 31st January 2025
