4. Details of our assessment

This Compliance Assessment Report (CAR) relates to Improvement Condition 49 (IC49). IC49 has been previously referred to and reviewed by Natural Resources Wales (NRW) in the earlier CAR forms CAR_NRW0043121, CAR_NRW0044339 and, CAR_NRW0045602.

As per the received IC49 submission the operator, Kronospan, had implemented differential pressure (DP) monitoring as a control measure for the monitoring of filter boxes across the site to achieve compliance with Permit Condition 3.6.1, Schedule 3, Tables S3.4 & S3.8. This included set points for alert levels and alarm levels; including process stops. In conjunction with scheduled preventative maintenance, DP monitoring was considered by the operator to be appropriate for the monitoring of filter bag/sock blinding to inform bag/sock replacement and for filter bag/sock leak/burst detection.

The NRW dust management plan audit as discussed in CAR_NRW0045800 identified a dust leak from the melamine filter boxes, which, had not been detected by DP monitoring. Kronospan have conducted a post incident investigation which, identified burst filter bags as the root cause. An internal Kronospan review of the IC49 methodologies has informed the resubmission of a revised document. Kronospan has identified that DP monitoring is appropriate and efficacious in the detection of bag blinding. For burst bag detection and leakage however, a more resilient, reliable and robust method is sought. The resubmitted IC49 discusses the reasons for this inefficacy.

The resubmitted IC49 details that further exploration in burst bag detection and residual dust monitoring will be undertaken in the the form of tribo-electric probes or inductive electrification technology. These solutions will be trialled and Kronospan has volunteered a date of 13/03/25 to provide their findings to NRW. NRW finds the proposed investigation and results submission date appropriate to conduct an effective solution driven trial.
