### 4. Details of our assessment

On the 12th December 2024, NRW carried out a site inspection at Mold Wastewater Treatment works (CM0031001) involving a visual check of the works.

The treatment works looked to be in working order at the time of the visit and the final effluent was clear.

All 4 storm tanks were full (2 blind) following the recent storm a few days previously. Usually the storm tanks start automatically returning about two thirds PFF (around 72-75 l/s at this site). The flow meter at time of visit was showing the PFF at 91l/s. Site commented that site used to return storm a lot quicker, but saw a change about 5 years ago (been number of new developments which could have contributed).

Flows in the watercourse still high, during the storm they overwhelmed parts of the site and sandbags needed to be used near pumphouse.

3 final tanks, 1 out of operation at present as requiring maintenance, not affecting treatment/final effluent.

Final polishing occurs with very fine screens to promote good phosphate levels (as well as ferric dosing earlier in process)

NRW will request flow and spill data from Dwr Cymru for this site and report back on this in a separate CAR form.

Noted that a new flow team has been set up recently by Dwr Cymru to make sure PFF being achieved etc.
