3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

Myself and Rob Harding attended site on a planned OSM inspection and were met by Dwr Cymru's Senior Operator for the area and the Operational Supervisor for the area. Thank

you for your time during the inspection. The day was bright and mostly overcast, with heavy rain the day before.

We inspected the site which was small and appeared to have not been visited in some time, as there were leaves and branches across the media bed. There was some carryover from the settlement chambers into the distribution channels on the filter bed that had caused blockages and some fungus to grow. The settlement chambers themselves appeared satisfactory and there was no indication of insufficient treatment. I have given this a C3 score as there is a risk of insufficient treatment following the blockages in the distribution channels.

ACTION: Ensure site is maintained in good condition to ensure adequate treatment of effluent.

On investigation it was unclear exactly where the outfall was, there was no access to the sample chamber adjacent to the site as it was rusted and damaged.

ACTION: Repair/maintain the sample chamber to enable representative samples to be taken.

I believe I was able to identify the outfall as there was a pipe discharging in the right location, however this was short of the watercourse and could cause pollution in lower/summer flows.

ACTION: Investigate the location of the outfall and assess its suitability/options for repair/upgrade.
