4. Details of our assessment

On Friday 6th December 2024 Angharad Clark and Hugh Martin attended Abertawe Metals for a routine inspection. They met with the operator and TCM. It was a dry cold day but was following a period heavy rainfall (Storm Bert).

This was a routine inspection, following higher category scores in the previous year, making it a high priority site.

W2D - The Site - Cat 3 breach - Permit condition 2.3.1

You have been given this category 3 breach under the above condition because during our inspection, there was pooling of surface water in the yard and it was evident that the drains were blocked. This is in breach of permit condition 2.3.1 which states that:

The activities shall, subject to the conditions of this permit, be operated using the techniques and in the manner described in the documentation specified in schedule 1, table S1.2, unless otherwise agreed in writing by the Environment Agency.



ACTION: Unblock the drains and maintain them in a manner that they remain functional by 24th January 2025.

Previous breaches

During the inspection, it was evident that a lot of the previous non-compliances had been addressed and mitigated. Batteries are now stored inside a building and there are no textiles stored on site.

General observations

The concrete pad in the yard requires continued maintenance. Whilst there was no breach of compliance regarding the pad, there were areas that will require repair/replacement imminently to prevent future scoring.

The TCM stated that he would soon be renewing his WAMITAB certificate. Please provide a copy of that certificate to NRW.
