### 4. Details of our assessment

The discharge was sampled twice in November due to the sampling chamber not being labelled prior to this, leading to the sampling being concertinaed. The discharge has

grossly failed on multiple parameters as indicated in the table below. A separate Compliance form will be issued for the samples taken on the 27th of November.

This CAR form is issued as a WARNING and future samples (not including those already taken on the 27th of November) will be taken as Formal Evidence Samples which would allow us to escalate our enforcement response, which could include Prosecution or Formal Caution.

#### Actions:

Please investigate the causes of the poor performance of the treatment plant and rectify all issues.

You have thus far failed to provide evidence that all clean water has been removed from the system and it is likely that this is contributing to the poor performance. The fact that the plant was flooded earlier this year indicates that this is still a problem. We therefore request that you provide a report on the treatment issues and infiltration status by 31st of January 2025.
