4. Details of our assessment

This Compliance Assessment Report is being produced following an unannounced site inspection conducted on Tuesday 3rd December 2024. At the time of the inspection the weather was dry but

overcast and the site was operational.

Luke Taylor (Waste Regulation Officer) and Holly Dyke (Enforcement Apprentice - Mid Wales Waste Regulation and Enforcement Team) of Natural Resources Wales carried out the inspection, being accompanied by staff member Mike Smith.

On arrival the site diary was checked and showed attendance by the Technically Competent Manager, David Gardner. The site management system was also available and briefly reviewed on site. It was mentioned that Mike Smith is in the process of completing his WAMITAB certification and will provide additional TCM (technically competent management) cover once completed.

W2A - Permitted Activities - Permit condition 2.1.1 - Action Only

As per Table S1.1 of the site permit, the waste must be stored and treated on impermeable surface with a sealed drainage system to foul sewer.

Upon inspection of the de-watering bays, the main drain for the bay appeared clear and operational. Whilst there was no evidence of any overspill of any waste to the back of the bays, there was some waste on top of the side walls of the bay, although this hadn't spilled over out of the bay itself. This was due to the waste pile being higher than the bay walls. Whilst there is no maximum storage height specified with the permit, the level of the waste needs to be reduced so that it is well contained within the bay walls to prevent spills.

ACTION - Lower the height of the waste deposited to within the bay walls. Deadline: 31/01/2025.

It was explained that the deconstructed bay would be re-constructed once a telegraph pole is moved following the completion of Newtown Active Travel Bridge.
