### 4. Details of our assessment

This Compliance Assessment Report (CAR) follows an unannounced site inspection at Hafod Landfill, in response to reports of odour.

Before attending site, officers completed offsite odour monitoring and recorded the following observations:

New Hall Road- No odours

New Hall Farm- agricultural / slurry odours

Shellbrook Drive- no odours

Vauxhall Industrial Estate- plastic and solvent odours. Drain/ sewer odours.

Heol Kenyon- plastic/ slight waste odour.

Heol Orsaf- waste odour & burning (resident having a bonfire in the back garden)

Tan Y Clawdd- burning/ bonfire odour

Worsely Avenue-no odours

Gwalia-no odours

Maes Isaf-no odours

Bangor Road- burning/bonfire odours present until passing under the railway bridge then waste odours detected while driving towards the site.

The road sweeper was cleaning the road in front of the site and there was minimal staining (no mud) on the road.

The Site Manager accompanied NRW staff during the inspection.

Localised odours were observed while a leachate tanker pumped out leachate from the leachate storage tank before removing it offsite. These odours disappeared once the tanker left site. The operator confirmed that several tankers had removed leachate during the

day. As stated in the Leachate Management Action Plan (November 24), Action 9, the operator is currently investigating/trialling whether a carbon filter pack can be installed on the leachate storage tank to reduce odours from exhaust gas from vacuum tankers. The operator is due to provide an update on the outcome of this trial to NRW in early 2025.

Waste odours were observed when filter cake (permitted waste) was tipped in the active cell. Once tipped, this waste was immediately covered in line with management system procedures and odours could not be detected. The site has an adequate supply of daily cover material to ensure the waste on the active cell is covered at the end of the working day.

NRW are currently reviewing waste acceptance procedures at the site and the outcome of this work will be discussed in a separate CAR.

There were minimal landfill gas odours observed at the time of the inspection.

Following the inspection, officers completed offsite odour monitoring and recorded the following observations:

Bangor Road-no odours

Y Gesail- no odours

Heol Orsaf- no odours

Heol Kenyon-no odours

Vauxhall Industrial Estate- plastic, solvent and waste odours.

Tan Y Clawdd & Nant Park Estate- no odours

New Hall Road- no odours.
