### 4. Details of our assessment

This Compliance Assessment Report (CAR) follows an unannounced site inspection at Hafod Landfill.

Before attending site, officers completed offsite odour monitoring and recorded the following observations:

New Hall Road- agricultural / landspreading

Shellbrook Drive- agricultural / landspreading

Vauxhall Industrial Estate- Sweet chemical odour coming from the drains

Heol Kenyon- cut grass

Heol Orsaf- no odours

Tan Y Clawdd- no odours

Worsley Avenue- no odours

Gwalia-no odours

Maes Isaf-burning odour

Officers were met by the Site Supervisor who accompanied them around the site. Works to install the new gas ring main had progressed and these were expected to be completed within the next week.

Mild, transient landfill gas and waste odours were observed when stood near the active tipping cell.

The last waste load of the day had been received and the operator was in the process of applying daily cover over the active tipping cell.
