4. Details of our assessment

This Compliance Assessment Report (CAR) follows an unannounced site inspection at Hafod Landfill that was carried out in response to reports of odour.

Weather conditions were relatively still with a slight breeze blowing from the south west.

Before attending site, officers completed offsite odour monitoring and recorded the following observations:

New Hall Road- waste odour

Shellbrook Drive- no odours

Vauxhall Industrial Estate- warm plastic odour

Heol Kenyon- agricultural silage and slurry odours

Y Gesail- no odours

Ruabon Road- agricultural silage and slurry odours

Tan Y Clawdd- no odours

Worsley Avenue- no odours

Gwalia- no odours

Maes Isaf- no odours

Bangor Road- waste odour near landfill site entrance.

Officers were met by the Group Environmental Manager who accompanied them around the site. The operator was carrying out site works to install a new 250mm gas collection pipe across a bench of cell 5a and along the sidewall of cell 5b. The intention is to form a ring main to allow landfill gas to be extracted in two different directions to minimise any vacuum losses, reducing the potential for odours, within the system.

As noted above, localised odours from the landfill were observed by the site entrance and

along New Hall Road while these works were carried out. These works are necessary for continued management of landfill gas as the site develops. The operator was carrying out the works while the wind was blowing towards the north-east/ east (away from the main housing estates) with the intention of completing them within the shortest timescale to minimise the potential for odours.
