3. What will happen next?

4. Details of our assessment

In accordance with permit condition 3.2.1b) Natural Resources Wales received a "Stage 2: Full investigation proposal" from DCWW on 20th December 2024, although it was late and due on the 25th November 2024. Due to the "full investigation proposal" report not received within the 3 month deadline NRW scores this breach as a CAT3.

Action

In order to identify the cause of the Trigger Breach Notification DCWW are required to investigate further. DCWW propose to conduct further desktop investigations and hydraulic modelling to identify the cause of spill. The deadline for this action is **17th February 2025**.
