4. Details of our assessment

This CAR form is being generated as a response to an incident self reported by Dwr Cymru and recorded as WIRS number 2415096. This was following a short term loss of the sludge blanket on one settlement tank at Treborth sewage works.

OSM and UWWTD samples were taken of the final effluent around the time of the loss of the blanket. The OSM sample result came back with a solids result of 437mg/l, as compared to the Upper Tier limit of 150mg/l and a Biochemical Oxygen Demand (BOD) of 139mg/l, as compared to the Upper Tier limit of 100mg/l.

The breaches have been classed as C2 as per guidance.

Please explain what actions will be taken to prevent a re-occurrence.
