4. Details of our assessment

This abstraction license is held by Swansea Council for the purpose of topping up two amenity lakes to maintain water level, during periods of dry weather. A maximum daily volume of 209m³, and an annual volume of 20,000m³ is permitted to be abstracted from the Tawe at National Grid Reference

SS 68235 98979 for this purpose and abstraction is permitted at any time of year.

You have confirmed to us that the abstraction has not been required for the last 5 years and have provided annual returns to demonstrate this.

Be aware that if water levels are low enough for the abstraction to be required, it is likely that the Tawe at Ynystanglwys Gauging Station will be below 0.226m and you will be required by condition 9.2 of the license to cease abstraction.

Due to the long period of no use, please ensure that the abstraction point is checked and is fit for purpose before it is next used. This includes ensuring that the installed meter is recording accurately (condition 7.1.iii), the intake pipe is of a diameter no greater than 225mm (condition 3.1) and an intake screen with bar spacing no greater than 3mm is in place at the point of abstraction and is in good condition (condition 9.3)
