4. Details of our assessment

The operator has submitted a waste phasing plan for waste disposal activities within Cell 9. The plan details how disposal activities in Cell 9 will be managed to minimise emissions of landfill gas; from the initial deposit of waste at the base of the Cell, through to the installation of capping and gas abstraction infrastructure.

The cell has been constructed as three sub cells (Sub Cells 9 A – C) which will be filled sequentially to minimise open areas of waste. Capping and gas abstraction infrastructure will be installed in a phased manner as the waste mass develops. A Construction Quality Assurance (CQA) Plan for the installation of the gas abstraction infrastructure has already been submitted and reviewed (CAR_NRW0045814).

Cell 9 will initially be developed as a standalone cell, physically separated from the adjacent cells (Cell's 6 – 8). This is due to the hydrogen sulphide content of the landfill gas currently being generated from waste deposits within the adjacent cells. These cells will remain temporarily capped until the Operator can demonstrate there is no risk of malodorous emissions arising from the release of landfill gas.

The waste phasing plan is presented in Geotechnology Report Number 2472r1v1d0924 – “Cell 9 Infilling Plan”. Dated: December 2024.

NRW accept the waste phasing plan and the document will now form part of the permit; incorporated under Operating Techniques. The waste phasing plan should be regularly reviewed to ensure it remains appropriate as the filling of the cell progresses. Any proposed revision must be submitted to NRW for acceptance.

Throughout waste disposal activities within Cell 9, the Operator should ensure that:

- The size of the active tipping area is minimised, so that only the smallest possible area of waste is open.
- Emissions from the waste flanks are minimised.
- The gradient of the waste flanks is suitable to allow for the installation and maintenance of the capping and gas abstraction system.
