4. Details of our assessment

Introduction

This Compliance Assessment Report was completed following a site visit by NRW on 30th of October 2024. The aim of the visit was for a general catch up of future plans at the site and to assess the W1 Emissions to water treatment processes. The Environment Manager and the Environment Assistant accompanied the Industry Regulation officer during the visit.

Future plans

A conversation took place between the above parties regarding future plans for the site. Due to commercial confidentiality these will not be listed in this report.

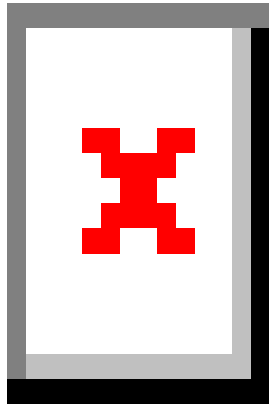
Site assessment

The processes around the treatment of waste water, covered in the Environment Permit conditions for W1 - Emissions to Water as below, were shown and explained by the Environment Manager.

Waste water treatment

Waste water from the paper mill is pumped to a Dissolved Air Flotation (DAF) water treatment process that removes contaminants from wastewater using aerobic digestion by using air to create bubbles that adhere to suspended solids:

1. **Air injection:** Air is injected into the wastewater under pressure.
2. **Bubble formation:** The air is released into a flotation tank, where it forms tiny bubbles.
3. **Contaminant attachment:** The bubbles attach to suspended solids,
4. **Floating:** The contaminants rise to the surface and form a floating bed.
5. **Removal:** A scraper or skimming device removes the floating contaminants





The contaminants are pumped to a skip (See below 2 images) for removal off site.





Treated water is pumped to sea (See below image) and any water that exceeds suspended solids threshold is recirculated in the system for further processing.



Alarm systems are in place and a manual checking schedule is also in operation to check that systems are operating effectively.

All systems were operating satisfactorily at the time of the visit. No further action is required.
