As agreed in the previous discharge of these conditions, the licence holder is carrying out the met mast removal in two parts. The lattice mast (Activity 1) was removed in July 2024 with the removal of the Monopile (Activity 2) planned between March 15 – May 15 2025. The biosecurity risk assessment has been updated to cover Activity 2 and an update to the ports that vessel 'Wind Server' has used in the past 12 months including up to its arrival in Holyhead before sailing to Gwynt y Mor Offshore Windfarm.
