4. Details of our assessment

At 10:30 on the 10th December 2024 a site inspection was undertaken by NRW officer Phil Harper, Senior Industry & Waste Regulation. The purpose of the inspection was to explore noise sources at Synthite following a report of offsite noise pollution originating from an area to the North of the Alyn Works site.

At the time of the inspection the site was operational.

Various noise sources were identified during the visit, which could result in noise to the North of the site. A high level assessment was carried out, considering the effect of barriers such as buildings between the noise sources and the location of the report.

A subjective assessment of site noise was made at the site boundary close to the reported location to provide an increased understanding of what noise sources were likely to be audible.

At 12:40 a subjective noise assessment was performed at the BLACK BROOK area. At this location the site was audible.

Natural Resources Wales intend to investigate offsite noise levels further in early 2025.

Action 1: The operator should indicate whether a noise management plan has been prepared for the site in accordance with the permit conditions discussed in section 3.4. by the **10th January 2025**.

Action 2: If a noise management plan has been prepared for the site, submit the document for review by the **10th January 2025**.
