4. Details of our assessment

On Thursday 19th December 2024 Natural Resources Wales officers attended site.

This was a routine site inspection for permit ref EPR/FB3734RP which was carried out by Waste Regulation

Officer Ian Thomas.

On arrival at site, i met with Steve Amos, Operations Manager for the site. Mr Amos introduced me to Paul Dromgoole, one of the owners, and the technical competent manager, Martin Womack.

Prior to the site inspection, we had a conversation regarding the ongoing plans for the site. There will be no change to the permitted area, construction of the new layout has begun with the newly acquired areas undergoing preparation. The planning has been approved. Dromgoole also carried out a meeting with local residence to answer any queries and questions they had regarding the site. The feedback was positive and the company plan to work alongside residence to minimise any disruption.

The site has limited access and has security systems and cameras covering the area.

I completed a walk around the site accompanied by Martin Womack, noting the process of waste brought in via tipper vehicles, some of the inert waste being treated, and some 6F2 product stored. The site was laid out as per previous visits. Martin explained where the new one way road system will be going and ensuring the permitted area will not be exceeded.

On return to the site office, Waste Transfer Notes were viewed, all relevant paperwork was available and looked to be in order.
