Environment Officer Eleanor Davies attended site for an unannounced site inspection. I was welcomed on site by Craig Stiens and shown around site by another member of staff.

The yard is small and well organised. All segregated waste is stored in skips in the external yard area. Mixed waste is stored in skips and manually separated within the building.



The building is served by two drains on either entrance which lead to an interceptor. The drains on both entrances were damaged due to general wear and tear from machinery tracking over them. Upon discussion I was informed that at least one drain would be fixed over the coming weekend and the other within the next few weeks. **Please provide me with evidence that this work has been completed by 28/02/2019.**



Section 2.1. of the management system states "There is no sealed drainage system. All liquids from wastes will be contained within the building..." This does not marry in with what was observed and discussed on site. At the time of inspection it was stated that the drains servicing the building discharged into a large interceptor tank. The management system we have on file also has a section titled "Appendix 1 - Site Plans" however we do not have copies of any plans on file. **Please provide me with a copy of any plans you have on file associated with the management system along with an updated drainage plan showing where the drains are, where the interceptor is and where the interceptor drains to e.g. mains sewer by**

28/02/2019. Please also update your management system clarifying this section.
