Environment Officer Eleanor Davies attended site for an unannounced site inspection. I was met on site and show round by Mark Swain, Operator and TCM. At the time of inspection site was busy but well organised.

The site is well secured with high, well maintained security fencing around it's perimeter and lockable gates.



All materials on site were stored on an impermeable surface, serviced by an interceptor that discharged to the foul sewer.



Depolluted vehicles are stored in the external yard area on the concrete pad or on specialised metal racking. The site was busy with a lot of vehicles on site however still appeared to be well organised.





Lead Acid batteries are stored in plastic battery containers within the depollution building while being filled. Once filled they are sealed with a lid and plastic wrap and stored in the external yard area pending removal from site.



Since the last inspection a bespoke table has been installed within the depollution building with integral drainage. This table allows the residual oils and fuels to be captured when the parts and engines are cut up.



Reusable parts are tagged and stored on racking within a building. These tags have barcodes that allow the individual parts to be tracked ensuring traceability.
