Environment Officer Eleanor Davies attended site for an unannounced site inspection. I was met on site and shown round by a member of staff. This site is smaller than the main yard in Winch Waun and appears organised and well run.

Reusable parts are stored within a building on racking. Each part is labelled with a barcode to ensure traceability. The wracking is well organised, clean and tidy.





Cars are depolluted within a building on an impermeable pad using specialist depollution machinery.





Parts and depolluted vehicles are stored in the external yard on an impermeable pad serviced by an interceptor which drains to the foul sewer.



Some areas of the impermeable pad show evidence of wear and tear. Please ensure that these are regularly maintained to ensure the integrity of the impermeable pad.
