Schedule

The notice specifies what you need to send and the date it must be sent by. If we do not receive it by the date set out in the notice, then we may treat your application as having been withdrawn.

Please provide:

1. If there is a temporary storage of manure at the site, then provide a manure management plan detailing:
 - o The management of litter.
 - o Storage methods of litter ready for the use of spreading or for the collection of a third-party.
 - o The spreading area of litter within the installation boundary.
 - o A plan to keep clean and dirty water separate, along with the capacities of the both clean and dirty water tanks.
 - o The manure management plan should be produced inline within Natural Resource Wales, [Guidance for Poultry Units: planning permission and environmental assessment](#)
2. A site drainage plan, which should;
 - o show the direction of flow water
 - o be colour coded to clarify the difference between clean (blue) and dirty water flows (red)
 - o identify any diverter valves
 - o identify the location of any watercourses, ponds, soakaways, swales etc
 - o identify any dirty water tanks and state capacity
 - o identify the location of any mains water stop-tap, boreholes, wells, springs etc.
3. Amend the ammonia modelling report to include;
 - o The maximum annual mean nitrogen and acid deposition rates for receptor numbers (51-73) in Table 6. *“Predicted process contribution to annual mean ammonia concentrations and nitrogen deposition rates at the discrete receptors”*.
