4. Details of our assessment

This report details the site visit made on the 18 December 2024 to Associated British Ports, Newport, permit reference number EPR-AB3699FY.

Natural Resources Wales (NRW) Officers Greg GARDNER, Carla CURTIS and Chris BURGE attended the Associated British Ports (ABP) site at Alexandra Docks, East Way Road, Newport, NP20 2NP for a unannounced routine site inspection at 10:30am. The weather was muggy and reasonably mild at the time of the inspection.

PERMIT BREACHES / ACTIONS

No permit breaches / actions have been identified during this site inspection.

GENERAL OBSERVATIONS

The site was not operational at the time of site inspection with wood chip that had been processed at South West Wood Products Ltd (next door to site) stored on site ready for export.

SITE INFRASTRUCTURE

The flooring on site was in good condition with no apparent damage visible. General housekeeping on site was maintained to a good standard and no causes for concern were identified. There was no excessive noise along with no visible airborne dust present during the site inspection. There was also no offensive odours witnessed by NRW Officers. The wood material on the ABP site had been processed by SWWP Ltd, which was pending export from Newport Docks via ship (see photo 1).

A street sweeper was present on site ensuring any excess wood chip / dust was removed to prevent potential harm to the environment / person(s). Good practices were witnessed by NRW Officers with regards to fire prevention and mitigation such as sufficient fire breaks and low stockpile heights. Please ensure continued compliance with your sites FPMP document in relation to stockpile heights / sizes as well as implementing sufficient fire breaks in order to prevent highly combustible material such as this from igniting.

There was no evidence of wood chip escaping and venturing into the nearby watercourse due to metal barriers along the waters edge to prevent any potential overspill. This evident on a previous site inspection (CAR_NRW0045195). Please continue this good practice in order to prevent any potential emissions to water.
