### 4. Details of our assessment

This report form relates to two historic breaches of your permit (ref BP0253201) conditions identified by our sampling team from a routine sample taken at Penygroes Concrete Products Ltd on the **31/07/2023**.

The two breaches identified were:

Condition 6 a) of your permit authorises a pH of 9. Our sample gave a reading of 12.06

Condition 6 b) of your permit authorises a suspended solids limit of 80 mg/l. Our sample gave an analysis of suspended solids of 171 mg/l.

We have not identified any further breaches of the permit conditions since this sample was taken. NRW will arrange a site visit to discuss the permits conditions over the next few months.
