4. Details of our assessment

Bayliss Recovery Ltd Site Visit, Tremorfa Industrial Estate, Cardiff (EPR/WB3893HZ) – 15/01/2025

Environment Officers Craig Coleman, Gareth Morris, and Carriers and Brokers Officer Andrew Prestt visited the Bayliss Recovery Ltd facility in Tremorfa, Cardiff; on 15/01/2025 to undertake an unannounced site inspection to assess compliance with the sites Environmental Permit (EPR/ WB3893HZ), and to assess the sites compliance with The Hazardous Waste (Wales) Regulations 2005, the Waste Assessment Report (WAR) will be attached to this form. The weather on the day of the inspection was fair with no rain or wind. The site is in an area of Cardiff known for scrap metal and ELV operators sees a sizable throughflow of metals and waste batteries. The site is permitted to undertake depollution activities as part of their environmental permit, but this activity is infrequently utilised as the business focuses on sorting and bulking metals and other wastes for onward transport and recovery.

We reported to the site office upon arrival and met Mr. Andrew Bayliss, a company director who accompanied us on our site inspection. The sites Technically Competent Manager, Mr Ian Lewis was at another Bayliss site overseeing an operation there.

The site is secured by a boundary fence and a manual gate which is closed and locked when the site is closed. The fencing and gate, which are substantial, were all in a good state of repair during the site visit. The site has high definition CCTV and thermal monitoring, which is monitored through non-operation periods by a security firm.

Waste is stored in the yard and sorted in to two distinct piles - Ferrous and non-ferrous. The waste piles on site, though large did not appear to be excessive and they are well separated into their categories. This waste undergoes treatment in the form of shearing to reduce it's size for ease of transport. Other wastes such as batteries are kept indoors within battery boxes before being shipped for recovery. Tyres are collected to extract the rims and are deposited into a large container and are transferred in bulk to Creigiau Tyres. The site does accept catalytic converters from individual and bulk sellers within the area. These are maintained uncrushed on site before shipping for recovery. Hazardous wastes were not mixed with non-hazardous wastes. At the time of the visit all hazardous wastes being stored indoors.

The Technically Competent Manager for the site is Mr Ian Lewis and his continuing competency is valid through to 04/03/26.

The sites Environmental Management System (EMS) has been provided upon request.
