4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised following a review of waste returns submitted to NRW from Q1 2020 to Q3 2024.

All waste codes accepted to site comply with Schedule 2 of your permit except for Q3 2021 when waste type 16 10 02 contaminated site run off was accepted to site. This was raised and scored in a previous CAR form - NRW0038707.

The waste returns submitted for Q1 to Q3 2024 show the waste accepted as exactly the same waste types, tonnages and Local Authority Area for each quarter submitted, see below:

Classification of landfill leachate.

Landfill leachate is likely to be classified with a mirror waste code 19 07 02*/19 07 03 . In order to be classified as 19 07 03 (i.e. non- hazardous) a waste assessment must be completed prior to the removal from the place of production in line with the technical guidance WM3 -Guidance on the classification and assessment of waste.

The non-hazardous waste code 19 07 03 should not be assigned to the waste unless it can

be shown the waste does not display any hazardous properties.

Action 3.

Provide the testing and supporting information that has determined your classification of the leachate as non-hazardous waste 19 07 03.
