4. Details of our assessment

This compliance assessment report is being produced following an unannounced compliance visit to Rhayader Depot on Thursday 12th December 2024. The inspection was conducted by Luke Taylor (Waste Regulation Officer) and Jeremy Goddard (Team Leader -

Waste and Enforcement Team Mid Wales).

The officers were accompanied throughout by Nigel Hicks (Waste and Recycling Area Manager) and the site was operational at the time of the visit. The weather was dry and overcast, with no wind.

General Observations

The officers inspected the main transfer building and there was no noticeable odour present, with all waste being stored within the confines of the relevant bays.

The plastics bay on the upper yard was inspected and found to be almost full. Nigel Hicks explained to officers that there had been a breakdown of machinery at the councils Brecon site, resulting in more waste being stored than usually. This was in the process of being addressed and, since the time of the inspection, evidence has been supplied confirming that the quantity of waste being stored has been reduced.

The site management system documents were checked in the site folder and found to be up to date at the time of the visit.

No evidence of non-compliance was identified.
