4. Details of our assessment

This compliance assessment report has been raised in response to a Schedule 5 Notification submitted by Knauf Insulation Limited. The incident took place on the 10/12/2024. The notification was sent in response to WIRS 2415298 being sent to site.

Emissions to water, air or land

The operator reported that due to a faulty pressure measurement in the top of the cupola, they were not able to achieve a consistent pressure of -0.5mbar at the top of the cupola which, is the normal operating condition.

This resulted in the operator seeing fugitive emission (CO, CO₂, particulates and other chemicals that are released by the combustion of coke from coal) coming out of the top of the cupola building via the louvres on Tuesday afternoon.

This was detected offsite by a member of the public who filed an incident report with Natural Resources Wales (NRW). The operator also confirmed that at the time the incident was reported the wind direction was carrying these fugitive emissions towards the area that the incident was reported from.

The operator was already investigating the unusual process variability around control of the cupola when the incident came in. They then switched the mode of operation of the cupola, where flow is used to control rather than the pressure. Changing from pressure (vacuum) based control to flow control resolved the issue, stopping the fume from the top of the cupola.

This has resulted in the following score:

(IR3A) Emissions to water, air or land. Permit Condition 3.1.1. Compliance Score C3.
