**4. Details of our assessment**

This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q4 (October - December) 2024 monitoring returns by Dunbia (UK) for activities at Teify Park Abattoir and Meat Processing Plant, Lampeter Road, Llanybydder SA40 9QE under permit EPR-BV9683IH.

This CAR was undertaken on 15 January 2025. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS has been altered to 31 December 2024.

**Q4 2024 Monitoring Returns****Emissions to water** – Q4 Water

The returns for reporting of sampling and analysis of emissions to water (other than sewer) to emission point W2 for Q4 2024 (1 October - 31 December) were submitted to NRW on 9 January 2025.

The parameter listed for emissions to W2 were:

(i) Total suspended solids, (ii) pH, (iii) BOD, (iv) Ammonia, and (v) Volume/Flow rate.

- The monitoring data was sent within the Q4 reporting period, which is **compliant** with permit condition 4.2.3.
- The monitoring was conducted inside the Q4 monitoring period, which is **compliant** with permit condition 3.6.1.
- The monitoring returns submitted includes reporting of monitoring carried out in respect of the parameters and emission points specified in table S4.1 of schedule 4, which is **compliant** with the environmental permit.
- Based on the reports submitted by the operator, all other emissions at the monitoring points appear **compliant** with the specified limits over the Q4 2024 reporting period.

**Quarterly Waste Effluent Inputs to ETP** - Form 4.2.5

This document was submitted to NRW on 9 January 2025.

- This data was sent within the reporting period, which is **compliant** with permit condition 4.2.5.
- The report details a NIL return.
