4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q4 (October - December) 2024 monitoring returns by Materials Recovery and Energy Centre for activities by Neath Port Talbot Country Borough Council at Crymlyn Burrows, Swansea, SA1 8PZ under permit EPR-BJ5775IF.

This CAR was undertaken on 15 January 2025. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS has been altered to 31 December 2024.

Q4 2024 Monitoring Returns

The returns for reporting of sampling and analysis of emissions for Q4 2024 were submitted to NRW on 1 November, 2 December, and 2 January for the months of October, November, and December 2024 respectively. The following documents have been submitted and reviewed:

The monitoring data was conducted within the Q4 2024 monitoring period, which is **compliant** with permit condition 3.5.1.

The monitoring data was sent within the Q4 reporting period, which is **compliant** with permit condition 4.2.2.

The monitoring data was reported in accordance with Table S4.1 and S4.4, which is **compliant** with permit condition 4.2.4.

Emission point A2 remains disconnected to any plant equipment on site. As the Waste to Energy Plant was decommissioned in 2013 all emissions to air have been submitted with NIL result.

Based on the reports submitted by the operator, all other emissions at the monitoring points appear

compliant with the specified emission limits over the Q4 2024 reporting period.
