The purpose of the site visit was to assess compliance with the environmental permit held by TE, reference EPR DB3993HD. During the time of the visit the permit was held by Trojan Electronics Ltd who were in administration. A permit transfer application had been submitted towards the end of 2018 and this was subsequently determined and issued on 14 February 2019.

The operations remain unchanged from those operated by Trojan Electronics Ltd, in that TE accept returned electrical items that have been classified as waste. These are all logged in to the internal management system individually. This ensures that they are fully traceable throughout the assessment and refurbishment process. Once logged in, they are sent from the reception area to the refurbishment area. The items are assessed and where possible refurbished for re-sale. CW confirmed that they assess and refurbish over 80% of items received.

PR confirmed that he is employed by TE as their technically competent person in accordance with condition 1.1.4.

A single consignment note for incoming and outgoing waste was taken for assessment. If any issues are identified, this will be provided under separate cover.

There were no non-compliances identified during the compliance visit.
