Introduction

This Compliance Assessment Report (CAR) is an assessment of the monitoring results for Quarter 3 (Q3) and Quarter 4 (Q4) covering July to December, which were submitted by CWM Environmental Ltd (the Operator).

Scope

The following monitoring returns and reports have been assessed within this Compliance Assessment Report (CAR):

- Quarter 3 Assessment
 - CP3735PB Nantycaws Landfill Q3 2024 Leachate.
 - CP3735PB Nantycaws Landfill Q3 2024 Surface Water.
 - CP3735PB Nantycaws Landfill Q3 2024 Groundwater.
 - CP3735PB Nantycaws Landfill Q3 2024 Gas.
- Quarter 4 Assessment
 - CP3735PB Nantycaws Landfill Q4 2024 Leachate.
 - CP3735PB Nantycaws Landfill Q4 2024 Surface Water.
 - CP3735PB Nantycaws Landfill Q4 2024 Groundwater.
 - CP3735PB Nantycaws Landfill Q4 2024 Gas.

Quarter 3 2024 Monitoring Returns

Q3 monitoring data was submitted by the Operator on the 25th of September 2024 detailing measurements taken in relation to the following permit requirements:

- **Table S4.1** – *Leachate Level Limits and Monitoring*
- **Table S4.3** – *Point Source Emissions to Water (Other than Sewer)*
- **Table S4.5** – *Trigger Levels for Emissions into Groundwater*
- **Table S4.6** – *Landfill Gas in External Monitoring Boreholes*

This data was sent within the reporting period (28 days), which is **compliant** with permit condition 4.2.3.

The submitted data fulfilled all monitoring requirements outlined within permit condition 3.6.1a to 3.6.1d.

Leachate Level Limits and Monitoring

There were no reported exceedances of leachate permitted levels or 'compliance limits' (formerly trigger levels) during the Q3 reporting period.

Point Source Emissions to Water (Other than Sewer)

There were no reported exceedances of permitted levels noted during the Q3 reporting period.

Emissions into Groundwater

The Operator reported an exceedance of Cadmium (Cd) limits on the 3rd of July 2024, with an illustrated figure of 0.000101mg/l. This was subsequently re-tested by the Operator on the 22nd of July 2024 and found to be **compliant** with the permitted values.

A Schedule 6 Notification regarding the exceedance on the 3rd of July 2024 should have been submitted to NRW within 24 hours, as required by permit condition 4.3.2.

Action: Ensure Schedule 6 Notifications regarding breaches of emission limit values are submitted to NRW within the specified timeframes.

Landfill Gas in External Monitoring Boreholes

There were no reported exceedances of permitted levels noted during the Q3 reporting period.

Quarter 4 2024 Monitoring Returns

Q4 monitoring data was submitted by the Operator on the 17th of December 2024 detailing all measurements pertinent to the aforementioned permit requirements.

This data was sent within the reporting period (28 days), which is **compliant** with permit condition 4.2.3.

The submitted data fulfilled all monitoring requirements outlined within permit condition 3.6.1a to 3.6.1d.

Leachate Level Limits and Monitoring

There were no reported exceedances of leachate permitted levels or 'compliance limits' (formerly trigger levels) during the Q4 reporting period.

Point Source Emissions to Water (Other than Sewer)

There were no reported exceedances of permitted levels noted during the Q4 reporting period.

Emissions into Groundwater

There were no reported exceedances of permitted levels within groundwater during the Q4 reporting period.

Landfill Gas in External Monitoring Boreholes

There were no reported exceedances of permitted levels noted during the Q4 reporting period.

This CAR report and assessment was undertaken on 17th of January 2025. However to ensure that the non compliance score is attributed to the correct financial year (for billing) the date on CARS system has been altered to the 31st of December 2024.
