## 4. Details of our assessment

Unannounced site inspection undertaken by Natural Resources Wales. Officers were shown around site by the site supervisor.

### General Management (W1A)

Officers requested a copy of the [Environmental Permit](#) and [Environment Management System](#). The permit was made available but was not easily located.

**Action-** To ensure all staff have easy access to permit and working plan. As per permit conditions 1.3.1 and to send Natural Resources Wales a copy for your Environment Management System.

### Operations (W2A) (W2C) (W2D)

WEEE items were not store in an appropriate weatherproof covering at the time of inspection. This was due to the site being closed for 3 days and Frame having access to the site to drop of materials when closed.

**C3 breach** – To ensure all WEEE items are stored in the appropriate weatherproof covering as per permit conditions 1.1 Dii

Waste was separated and waste types on site were in line with permit condition 1.2.

Site drainage was well maintained and site drainage at time of visit was in good working order with permit condition 2.1

### Site infrastructure

Site boundaries were secured and all operations were being conducted in the site boundary as per permit condition 3.2
