4. Details of our assessment

This compliance assessment report is being produced following a site inspection in relation with a surrender application by the permit holder, Powys County Council for the Vastre site.

The inspection was conducted by Luke Taylor (Waste Regulation Officer) and Holly Dyke

(Enforcement Apprentice) of Natural Resources Wales.

The weather at the time of the inspection was dry and bright, with the officers being accompanied throughout by the site Technically Competent Manger, Nigel Hicks, and Laura Samuel, Powys County Council.

Prior to attending, the officers have reviewed the supporting documentation, supplied with the surrender application, along with previous Compliance Assessment Reports, and information relating to the site condition prior to operations commencing under this permit.

On attendance, the site was clear of all waste material, with no evidence of pollution present and no litter or debris visible. There was no machinery on site and it was in a clean and tidy state.



The storage bays were free of any waste, with no evidence of contamination, having only held plastics, cardboard and glass when in operation. Municipal food waste was always stored within a large skip, which has since left site. There was no evidence of any waste remaining where that once stood.
