### 4. Details of our assessment

On the 11th September 2024 Dwr Cymru notified Natural Resources Wales of a permit exceedance at Bangor Isycoed Sewage Treatment Works.

On the 3rd September 2024 BOD was recorded at 41mg/l against the regulations limit of 40mg/l.

This site benefits from the look up table procedure which allows a number of exceedances before and absolute failure is recorded. This result has been recorded as an exceedance.

Dwr Cymru have explained that they experienced a filter rotation issue on site. This was caused by previous blockages on the filter arms, leading to a short deterioration in the quality of the final

effluent.
