4. Details of our assessment

Quarterly reporting of emissions – Q4 (October – December 2024)

VOC monitoring returns for Sherwin Williams UK Ltd, Deeside Packaging Coatings, Parkway, Deeside Industrial Park, Deeside, Flintshire, CH5 2NN, permit no EPR/BU7545IM corresponding to Q4 2024 were received by Natural Resources Wales on the 29th November 2024 as required by permit condition 3.3.1(a), Schedule 3, Table 3.1.

A review of the monitoring returns was undertaken by Phil Harper, Senior Industry & Waste Regulation Officer on the 24th September 2024.

Emission point A3

Total Class A VOCs as Individual VOCs

Sampling for VOCs was undertaken at A3 on the 5th November 2024. A value of 103 g/h of VOCs has been reported against the permitted value of 100 g/h. Whilst this represents a permit breach at A3, the value lies within the uncertainty value of $\pm 20\%$ which has been provided for the analysis.

The return describes that the filling of ethyl acrylate which was being undertaken at the same time as the sampling of A3.

Permit condition 4.3 describes how notification should be sent to NRW if a breach is identified. Making reference to permit condition 4.3.2, notification for permit breaches should be sent to NRW using the Schedule 5 forms attached to the sites environmental permit. NRW is of the view that the operator has provided the information required by the forms within the return.

No Breaches have been applied on this occasion.

Action 1: Inspect the scrubber at emission point A3 to ensure that it is operating as designed by the 28th February 2025.

Action 2: For any breaches which are detected in future, ensure that notification is sent to NRW as described by permit condition 4.3.

No further emission limit breaches have been identified.

Please note: Emission point A4 is still under construction, therefore, no data is required at present.
