4. Details of our assessment

A notification has been received by Natural Resources Wales (NRW) that an Operator Self Monitoring (OSM) sample collected by Dŵr Cymru Welsh Water (DCWW) at Llanfair Clydogau Wastewater Treatment Works (WwTW) on the 17 January 2025 had an ammoniacal nitrogen concentration of 9.07 mg/l. The permit limit is 5 mg/l.

It is understood that this is the first exceedance for ammoniacal nitrogen at Llanfair Clydogau WwTW in the last 12 months. As 12 samples have been collected at Llanfair Clydogau WwTW in the last 12 months, under the look up table procedure, the exceedance does not classify as a permit breach. This Compliance Assessment Report (CAR) is therefore being sent to record the exceedance only.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.
