The purpose of the visit to Sony Pencoed was to discuss with the operator the changes that are required to be done for the permit to reflect the operations on site.

The operator had applied for a minor technical variation in August 2022 however due to the change in legal entity, a full transfer application was required. On this visit advice was given to the operator to apply for the full permit transfer to change the permit to the new name Sony will operate in Pencoed from April 2025. The application forms were shown on the NRW website, and a brief overview of the required information was given. Additionally, the operator was shown where to find guidance documents that would aid the transfer application. The operator will now progress with the application.

Action - Prepare and submit permit transfer application to NRW.

Following this, there was a query from the operator on the options for the site in the future with the potential for plastics and WEE wastes to be recycled on site. This is to reduce the sites carbon use on returning the wastes and decrease the logistic cost of movement. This is encouraged as it reduces the need for the transport of waste and the recyclability of materials on site.

Due to the smaller scale of operations from the proposed activity, the operator was shown the standard rule permits available on NRW's website, which may be an option for the site to use. This would be up to the operator to decide which permit best fits the practice in which they decide to move forward with. A quick check was done on the NRW mapping which showed no SSSI/SAC/Ramsars nearby which could have an impact on whether or not a standard rule permit can be used. An explanation was given that if there were no standard rule permits that fits in with the proposal then more than likely a bespoke waste permit will be required. Operator can email/call the officer if further information is required.
