### 4. Details of our assessment

Dwr Cymru notified Natural Resources Wales of an exceedance of Ammonia and Biological Oxygen Demand (BOD) at Gresford Waste Water Treatment Works on 7/1/25.

The final effluent sample taken on the 3/01/25 had 13.91mg/l of Ammonia compared to the look up table limit of 10mg/l. And 73mg/l of BOD compared to the look up table limit of 40mg/l. Despite exceeding the look up table limits they are within the maximum limits.

This site benefits from a look up table permit which allows a number of exceedances before a failure is recorded.

Dwr Cymru believe the root cause of this exceedance was a pump failure which caused a short term reduction in treatment quality. The pump was repaired and the level of treatment improved. This year, there is planned improvement works at this site to remove this pump.
